ADMINISTRATIVE ORDER NO. 2018-043

SSS SPORTS EXECUTIVE COMMITTEE

The following are the duties and functions of the Sports ExeCom:

- To recommend periodic enhancements and amendments on the Internal Rules and Regulations governing the sports activities/programs of the SSS:
- To coordinate with the different departments, offices and branches the implementation of various sports tournaments and other sports-related activities/programs;
- 3. To organize and oversee the various sports committees in coordination with the Performance Management and Employee Relations Department (PMERD) in the conduct of sports tournaments and other sports-related activities/programs as well as the participation of SSS to governmentsponsored sports activities, and
- 4. To submit yearly sports plans/programs to the President and CEO as well as the annual accomplishment report to the Corporate Policy and Planning Department (CPPD) through PMERD as the organic unit in-charge.

The term of office of the members of the SSS Sports Executive Committee shall be three (3) years or from year 2018 to 2021. The date of the succeeding election shall be on January 2021 to be conducted by the PMERD.

The SSS Sports ExeCom shall be accorded the same status of a Committee created by the Management and shall be subjected to existing guidelines under Office Order No. 237-P.

This supersedes Administrative Order No. 2014 - 007 dated 10 February 2014.
