

The ACOP Program requires pensioners to report to SSS annually to ensure continuous payment of their benefits under the Social Security Law.

ACOP through video conference (ACOP-VC) using the licensed software “Microsoft Teams” (MS Teams) is an additional option for pensioners residing abroad to comply with the program to avoid suspension of their monthly pension.



COVERAGE

All retirement-pensioners, survivor-pensioners, dependents and their guardians who are residing abroad and whose pension status is active or suspended due to non-compliance with ACOP may comply with the **ACOP-VC using MS Teams**.

SCHEDULE

The pensioner shall comply with the ACOP on the following schedule:

TYPE OF PENSIONER	WHEN TO COMPLY
Retirement-pensioner	Month of birth
Survivor-pensioner	Month of birth of the deceased member
Dependents and their guardians	Month of birth of the retirement-pensioner/deceased member

STEP-BY-STEP PROCEDURES

1 Request for ACOP-VC appointment through email at member_relations@sss.gov.ph or ofw_relations@sss.gov.ph using the format **ACOP-**

VC, Pensioner's Name, SS Number (e.g. ACOP-VC, Juan Dela Cruz, 01-2345678-9) as the email subject.

2 Wait for SSS' email confirmation on the ACOP-VC appointment together with the transaction reference number (TRN), requirements for ACOP-VC, and MS Teams Meeting link.

Note:

The pensioner must have an **MS Teams** application and suitable internet bandwidth.

➔ The pensioner may access MS Teams using desktop computer/laptop (Windows and MAC OS) with webcam or mobile phone/tablet (at least Android version 4.4/iOS version 10).

➔ The pensioner's gadget must be positioned in a well-lighted area during ACOP-VC.

3 Accept the calendar invite upon receipt of email confirmation from SSS.

4 On the appointment schedule, open the email confirmation and click “**Join Microsoft Teams Meeting**” link. All other applications must be closed during ACOP-VC to avoid interruptions.

5 Wait until the SSS agent accepts your request then present to him/her the TRN and documentary requirements.

6 After the video conference, wait for the acknowledgement on ACOP compliance and schedule of next ACOP-VC appointment through email.

➔ FOR OFW-CONTACT SERVICES SECTION (OFW-CSS)

- Monday to Friday from 6:00 AM to 9:00 PM

➔ FOR CALL CENTER SECTION – MEMBER COMMUNICATIONS AND ASSISTANCE DEPARTMENT (MCAD)

- Monday to Friday from 7:00 AM to 11:00 PM



DOCUMENTARY REQUIREMENTS

The pensioner must present any of the following:

➤ One (1) primary ID card/document, such as

- Unified Multi-purpose Identification (UMID) or Social Security card
- Alien Certificate of Registration
- Driver's License
- Firearm Registration
- License to Own and Possess Firearms
- National Bureau of Investigation Clearance
- Passport
- Permit to Carry Firearms Outside of Residence
- Postal Identity Card
- Seafarer's Identification & Record Book (Seaman's Book)
- Voter's ID Card

➤ Two (2) valid IDs issued by the host county governmental unit/agency where photo and signature are shown or in the absence of these, Certificate of Appearance issued by the Philippine Embassy/Consulate

Note:

- Name in presented ID cards/documents must match with name per SSS records.
- Expired ID cards/documents shall be accepted as identification provided it has signature and photo.

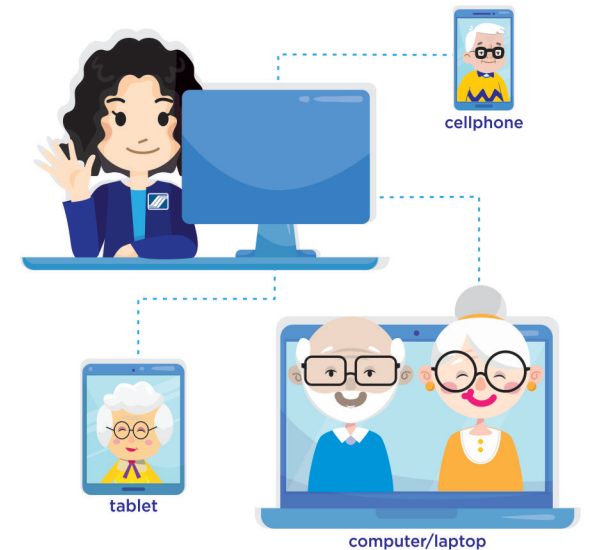
