	Query/Clarifications	TWG/BAC Reply
1	If the items/specs indicated in the technical specification is absolute, can we use an alternate that is available in the market?	Yes, we can accept any brand as long as it is within the specifications.
2	This is the 4 th advertisement, right? May we know the reason of failure of bidding in the past three advertisements?	There was no participating bidder on the first advertisement, on the second, there was only one participant who was disqualified due to their documentation. The third was disqualified due to documentation, too.
3	May we know what were the failure of documentation that caused the failure of bidding?	It was on the NFCC requirements and technical specifications. They failed to meet that requirement.
4	During the last bidding, it was not indicated that Pollution Control Officer (PCO) ID was required. Are you requiring the PCO certificate with ID?	It was indicated in the bidding documents that PCO ID should be accompanied by PCO Certificate.
5	Our SLCC caused our bid to be disqualified, is it really required that it should be Preventive Maintenance with Electro Contaminant Remover?	Yes, since our system is electro contaminant remover, so our requirement is with the same experience. And we are trying to prevent downtime. We are also preventing having a tutorial on how to conduct the electro-contaminant remover which may contribute to extensive downtime with STP operation.
