
PROJECT: REPLACEMENT OF TWO (2) 1.5MVA STANDBY GENERATOR SET AT POWERHOUSE AT SSS MAIN BUILDING

QUERIES/CLARIFICATIONS RAISED DURING THE PRE-BID CONFERENCE:

	Query/Clarifications	TWG/BAC Reply
1	We had a project before, it's 1250KVA but it did not meet the 50% of the ABC. However, we also had a project that is more than the ABC, but the capacity is smaller than required. Can we consider making these two contracts as aggregate to satisfy the SLCC or as our track record?	No. Based on our bidding documents, the Single Largest Completed Contract is what we are requiring which means a single contract only and is 50% of the ABC. At this point, we can no longer change the requirement of 50% of the ABC since it is already advertised. As per RA 9184, we can only use an aggregate of 2 or more contracts if, at the outset of the market research, nobody can comply.
3	Can we conduct a site inspection?	Yes.
3	Do we need to do a letter of request or any other requirement for the survey?	None is needed.
4	When we conduct the site survey, is it going to be a requirement? Will there be a certificate of site inspection needed to be attached to the bidding documents?	Yes. A certificate will be given for the site inspection. A date will be set so everyone can join. The deadline for written queries will be moved to Tuesday, October 10, 2023.
5	Regarding the muffler, does it mean we are going to use the old one and it just needs to be retrofitted to the new genset?	Yes, if compatible with the offered new genset and compliant to manufacture's standard.
6	What permits do you require from us to operate?	What we need are the necessary requirements for the application of Permit to Operate (PTO).
7	Will the PTO come from DENR or LGU?	It is from DENR.
8	Does the project have a copy of BOQ?	Yes, we will issue a soft copy of the BOQ together with the bid bulletin.
9	Can you issue the BOQ so we can immediately ask questions via the bid bulletin?	It is in the bidding documents. It is downloadable from the website, Form 02.
10	Who is the contact person for the site inspection?	TWG's Antonio V. Trinos, Jr. and Francis F. Flores. We should meet at the BAC Secretariat Department, 2 nd floor of the Main office, on Monday, 10:00 a.m.
11	Can a site inspection certificate be available even when we have not purchased the bidding documents yet?	Yes, for as long as you attend the site inspection. Purchasing the bidding documents can be done until October 19, 2023 before 2:00 p.m.
