**QUERIES/CLARIFICATIONS RAISED DURING THE PRE-BID CONFERENCE:**

	<b>Query/Clarifications</b>	<b>BAC Reply</b>
1	Are the sofas tufted with buttons or just tufted?	Sofa design shall be tufted with buttons
2	Is it loose cushions, the seat and back?	No. It shall be fixed cushions
3	About the SLCC, should it be specific to lounge chair or would you consider general furniture?	SLCC shall be Supply, delivery and installation of seating furniture designed for high traffic spaces (i.e. auditorium seating, lounge/lobby seating, gang chair seating)  This amends Section III. Bid Data Sheet. ITB Clause. 5.3.a
4	For the Single Largest Completed Contract, may we request for it to be Supply and Delivery of Furniture? This will mean more bidders can join. Also, lounge seating set is too specific.	
5	For the SLCC, can we consider the lounge seating set to seating model?	
6	Upon identifying the lowest calculated bidder, is it required to submit the actual design, or can we show a similar design so we can show our craftsmanship?	Mock-up sample must adhere to the technical specification and design of the subject item for bidding.
7	When would the submission be?	It is within non-extendible period of five (5) calendar days from receipt of BAC notice.
8	Upon notification for post-qualification, can we extend the 5-day period for the submission of samples?	No. The 5-calendar day delivery of mock-up is part of post-qualification and cannot be extended.
9	If ever the mock-up sample is submitted and did not pass, will there be a chance to have it rectified?	No. If the mock-up fails, that will be a ground for disqualification.
10	Can we request the detailed dimensions of the design?	Please refer to the attached detailed drawing issued in the Bid Bulletin.
11	The thickness of foam and metal was not specified. Also, the legs looked tapered; may we know the thickness of it?	The thickness of foam shall be 2" thick high-density foam and for the metal support shall be 1"X2" tubular welded type stainless steel in satin or brushed finish.
12	May we request copies of the pictures and drawings presented earlier?	Please refer to the attached drawing and pictures. <i>(submitted pictures are for reference only)</i>
