

**PROJECT: SUPPLY AND DELIVERY OF SERVICE VEHICLES FOR VARIOUS BRANCHES AND OFFICES (PASSENGER VAN)**

**QUERIES/CLARIFICATIONS RAISED DURING THE PRE-BID CONFERENCE:**

	<b>Query/Clarifications</b>	<b>BAC Reply</b>
1	Clarification on the requirement of 36 units of passenger van with SSS e-wheels Stickers and 36 units of passenger van with SSS Logos (painted), what if we will only bid for lot 1, does the rule on logo/stickers still apply?	Stickers as an alternate for the painted SSS Logo and other texts is acceptable. This is applicable for Lots 1, 2 and 3.
2	If we bid for only one lot, are we obliged to follow the ABC of 50% of our SLCC?	Yes. SLCC should be 50% of the ABC for the lot the bidder wishes to participate.
3	We are a multi-brand company; how do we go about our bids? Is it supposed to be per brand per bid or as a group of company, we will bid/propose for 2 or 3 brands?	The offered vehicle shall be of one brand/model. Multi-brand/model is not acceptable
4	Regarding the horsepower under technical specifications, will you allow 129 PS instead?	No.
5	Is the SLCC on a per lot basis?  If we bid for the three lots, the SLCC should be 50% of the lot with the highest ABC?  And not necessarily 50% of the entire project?	Yes. The bidder is required to submit SLCC for each lot provided that it should be at least 50% of the ABC per lot.  Yes.  No.
6	In the Schedule of Requirements of the Bidding Documents, the final destinations for lots 2 and 3 is the port where the branch is located. Is it going to be part of our expenses?	Yes, the delivery cost shall be borne by the winning bidder. Delivery of units for Lot 3 (Visayas and Mindanao) shall be up to port only. Please see Annex A of

		the bidding documents for the port destinations
7	How many copies of documents are we going to submit?  If we are going to participate in 3 lots, should we submit 3 sets of documents also?	3 sets, 1 original and 2 duplicate copies.  In the bid bulletin, it is specified which document is applicable for all the lots and which documents are needed to be separated per lot.
8	Regarding the 3-year Third Party Liability (TPL) Insurance from GSIS requirement, is one year acceptable?	The TPL requirement is three years, the standard 1 -year coverage shall be renewed annually for 3 consecutive years.
9	For the manner of submission of bid documents, is it required to submit the documents manually?	Yes. For now, the submission of bids is manual. We do not have a facility for online submission yet.
10	Clarification on the submission of Comprehensive Insurance from GSIS, is it also 3 years?	For the Comprehensive Insurance from GSIS, is only 1 year.
11	Is it possible to extend the delivery period for 160 calendar days?	The delivery period for Lot 1, 2 and 3 shall be 120 calendar days upon receipt of Notice to Proceed and Contract.
12	Regarding the painted SSS logo, is there a chance to use the sticker instead of painting?	Stickers as an alternate for the painted SSS Logo and other texts is acceptable. This is applicable for Lots 1, 2 and 3.
13	Is the security bond non-refundable?	Only the fee for the bidding documents is non-refundable, but the bid security is refundable.
