THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Approving Authority and Senior Vice President for Lending and Asset Management Group, **PEDRO T. BAOY**, its Vice President and Concurrent Acting Head for Administration Group, **DORENDA M. DASMARIÑAS**, duly authorized pursuant to Administrative Order No. 2023-009-c dated 19 July 2023 (Annex "A") and Office Order No. 2023-032 dated 23 August 2023 (Annex "B"), hereinafter referred to as the "**SSS**";

ROLANDO S. CORREA, of legal age, Filipino, Sole Proprietor of **KB KONSTRAK BILDING SOLUSYONS**, with business address at 42A General Segundo Street, Heroes Hill, Barangay Sta. Cruz, Quezon City, duly authorized pursuant to an Omnibus Sworn Statement dated 13 July 2023 (Annex "C"), hereinafter referred to as the "**CONTRACTOR**".

WHEREAS, the **SSS** is desirous that the **CONTRACTOR** execute the **Waterproofing Works of Main Office, Baguio and Davao Buildings [Lot 2: Roof Deck and Repair/Restoration of Rear Exterior Walls of Baguio Building]** (hereinafter called "the Works") and the **SSS** has accepted the Bid for **PESOS: SIX MILLION FOUR HUNDRED FORTY-FIVE THOUSAND EIGHT HUNDRED TWENTY-SEVEN AND 57/100 (P6,445,827.57)**, Philippine currency, by the **CONTRACTOR** for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
 - a. Philippine Bidding Documents (PBDs)
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any.
 - b. **CONTRACTOR's** bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Contractor's bidding envelopes, as annexes and all other documents submitted (e.g., Contractor's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from SSS' bid evaluation;
 - c. Performance Security;

- d. BAC I Recommendation for Award under Resolution No. 2023-I-064-7 dated 21 September 2023, approved on 02 October 2023; Notice of Award of Contract dated 06 October 2023 and the **CONTRACTOR's** conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **CONTRACTOR agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **PESOS: SIX MILLION FOUR HUNDRED FORTY-FIVE THOUSAND EIGHT HUNDRED TWENTY-SEVEN AND 57/100 (P6,445,827.57)**, Philippine currency, or such other sums as may be ascertained, **CONTRACTOR** agrees to perform the waterproofing works for the roof deck and repair/restoration of rear exterior walls of SSS Baguio Building in accordance with its Bid.
 4. The **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




