THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Approving Authority and Senior Vice President for Lending and Asset Management Group, **PEDRO T. BAOY**, and Concurrent Acting Head for General Services Division, **WENDELINO V. COMBOY, JR.**, duly authorized pursuant to Administrative Order No. 2023-009-c dated 19 July 2023 (Annex "A") and Office Order No. 2023-032 dated 23 August 2023 (Annex "B"), hereinafter referred to as the "**SSS**";

MARLYN R. ASONIO, of legal age, Filipino, married, and Owner and Sole Proprietor of **HANMHE INDUSTRIAL SALES AND GENERAL SERVICES**, with office address at Lot 1 Block 16 Avenue of the Philippines Phase II, Freeport Area of Bataan, Mariveles, Bataan, represented herein by her Attorney-In-Fact, **EDGAR A. ASONIO**, duly authorized pursuant to an Omnibus Sworn Statement dated 27 September 2023 (Annex "C") executed, hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Supply, Delivery and Installation of Air-Conditioning Units for Various Divisions, Branches and Service Offices (Re-Advertisement) [Lot 3: Visayas Divisions, Branches and Service Offices]** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: NINE MILLION SEVEN HUNDRED TEN THOUSAND SEVEN HUNDRED FIFTY AND 00/100 (P9,710,750.00)**, Philippine currency, (hereinafter called "the Contract Price").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
 - a. Philippine Bidding Documents including
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General; and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
 - b. **SUPPLIER's** Bid, including –
Eligibility Requirements
 - i. Philgeps Registration;
 - ii. Statement of Ongoing/Completed Contracts;
 - iii. Omnibus Sworn Statement.

Technical and Financial Proposals

- iv. Single Largest Completed Contract;
 - v. Bid Security;
 - vi. Net Financial Contracting Capacity;
 - vii. Schedule of Requirements and Statement of Compliance;
 - viii. Bid Form and Bid Breakdown;
 - ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT).
- c. Performance Security;
- d. BAC I Recommendation for Award under Resolution No. 2023-I-085-16 dated 09 November 2023, approved on 01 December 2023; Notice of Award of Contract dated 01 December 2023 and the **SUPPLIER's** conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **PESOS: NINE MILLION SEVEN HUNDRED TEN THOUSAND SEVEN HUNDRED FIFTY AND 00/100 (P9,710,750.00)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to Supply, Deliver and Install Air-Conditioning Units for Visayas Divisions, Branches and Services Offices in accordance with its bid.
4. The **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding


