THREE (3) YEAR CONTRACT FOR SECURITY SERVICES  
FOR MAIN OFFICE, EDSA LOT, POEA, NCR PROPERTIES  
AND NCR OPERATIONS GROUP (RE-ADVERTISEMENT)  
[LOT 4: NCR SOUTH AND WEST DIVISION]  
ITB-SSS-GOODS-2023-066

THIS **AGREEMENT** made between:

**SOCIAL SECURITY SYSTEM**, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Quezon City, represented herein by its Approving Authority, President and Chief Executive Officer, **ROLANDO LEDESMA MACASAET**, duly authorized pursuant to Administrative Order No. 2023-009-c dated 19 July 2023 (Annex "A") and Office Order No. 2023-032 dated 23 August 2023 (Annex "B"), hereinafter referred to as the "**SSS**";

**GOLDLINK SECURITY AND INVESTIGATIVE SERVICES, INC.**, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at Unit 502, 5th Floor, TGHC Building, 125 K-1st Street, Kamuning, Quezon City, represented herein by its President, **CRISPIN G. DANTES**, pursuant to a Secretary's Certificate dated 27 September 2023 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Three (3) Year Contract for Security Services for Main Office, EDSA Lot, POEA, NCR Properties and NCR Operations Group (Re-Advertisement) [Lot 4: NCR South and West Division]** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: FORTY-ONE MILLION NINE HUNDRED TWENTY-FOUR THOUSAND SEVEN HUNDRED THIRTY-SIX AND 28/100 (P41,924,736.28)**, Philippine currency, **per year** (hereinafter called "the Contract Price").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT**, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:

Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **PESOS: FORTY-ONE MILLION NINE HUNDRED TWENTY-FOUR THOUSAND SEVEN HUNDRED THIRTY-SIX AND 28/100 (P41,924,736.28)**, Philippine currency, per year or such other sums as may be ascertained, **SUPPLIER** agrees to provide Security Services for the NCR South and West Divisions (Lot 4) for three (3) years in accordance with its bid.
4. The **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding.
