

CONTRACT AGREEMENT
CONSULTANCY SERVICES FOR THE HUMAN RESOURCE-

THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Approving Authority and Executive Vice President for Branch Operations Sector, **VOLTAIRE P. AGAS**, and Senior Vice President for Human Resource Management Group, **JOSEFINA O. FORNILOS**, duly authorized pursuant to Administrative Order No. 2023-009-c dated 19 July 2023 (Annex "A") and Office Order No. 2023-032 dated 23 August 2023 (Annex "B"), hereinafter referred to as the "**SSS**";

PEOPLE DYNAMICS, INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at Unit 502 OMM-Citra Building, #39 San Miguel Avenue, Ortigas Center, Pasig City, represented herein by its President and Managing Director, **JOCELYN R. PICK**, duly authorized pursuant to a Secretary's Certificate dated 23 January 2024 (Annex "C"), hereinafter referred to as the "**CONSULTANT**".


WHEREAS, the **SSS** is desirous that the **CONSULTANT** execute the **Consultancy Services for the Human Resource-Organizational Development for Restructuring** (hereinafter called the "Works") and the **SSS** has accepted the bid for **PESOS: NINETEEN MILLION FOUR THOUSAND EIGHT HUNDRED THIRTY-TWO AND 00/100 (₱19,004,832.00)**, Philippine currency, by the **CONSULTANT** for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT**, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this **AGREEMENT**, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Terms of Reference;
 - (c) Request for Expression of Interest;
 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid forms, including all the documents/statements contained in the Consultant's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., Consultant's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the SSS' bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;

- (i) Performance Security;
 - (j) BAC I Recommendation for Award under Resolution No. 2023-I-110-1 dated 29 December 2023, approved on 30 December 2023; Notice of Award of Contract dated 30 December 2023 and the **CONSULTANT's** conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the **SSS**.
3. In consideration of the payments to be made by the **SSS** to the **CONSULTANT** as hereinafter mentioned, the **CONSULTANT** hereby covenants with the **SSS** to execute and complete the Works/Consulting Services and remedy any defects therein in conformity with the provisions of this Contract in all respects.
 4. The **SSS** hereby covenants to pay the **CONSULTANT** in consideration of the execution and completion of the Works/Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
