

	Query/Clarifications during the Pre-Bid Conference	TWG/BAC Secretariat Reply
1	On Technical Requirements – Color, the item being required does not have a Black color but "Space Gray". Can you consider such color?	Color: Silver or Space Gray. This amends Section VII. Technical Specifications
2	On Technical Requirement – Accessories (Stand and Smart Keyboard), can you consider both items as 1 and single accessory (Keyboard attached to the stand)	Accessories: Full-size keyboard with front and back protection and must be an original accessory. This amends Section VII. Technical Specifications.
3	On Technical Requirement – Connectivity, is it wi-fi and cellular?	Yes
