


- a.3 Statement of at least two (2) similar contract completed **within the period of five (5) years** prior to the date of submission and receipt of bids, the aggregate amount of which should be equivalent to at least fifty percent (50%) of the ABC and the largest of these similar contracts must be equivalent to at least 25% of the ABC.

- a.4 NFCC Computation or committed Line of Credit (form supplied)
 - a.5 JVA, in case of Joint Venture – Class “B” Documents (Each partner of the joint venture shall submit the legal eligibility documents. The submission of technical and financial eligibility documents by any of the joint venture partners constitutes compliance, except for SSS Clearance that must be complied by all JV partners);
