### **3. Documentary Requirements**

In case of uploaded document/s, which validity period had already expired, submit the updated document/s.

- a.2 Statement of all its Ongoing Government and Private Contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;
- a.3 Statement of Single Completed Contract similar to the project to be bid within the period of **five (5) years** and similar contracts must be equivalent to at least 50% of the ABC for each lot;
- If the bidder will participate in more than one (1) lot, the basis of the SLCC shall be the largest ABC between/among the lots the bidder intends to participate in.
- a.4 NFCC Computation or Committed Line of Credit (If the bidder will participate in more than one (1) lot, the basis of the NFCC shall be the largest ABC between/among the lots the bidder intends to participate in).
- a.5 JVA, in case of Joint Venture – Class “B” Documents (Each partner of the joint venture shall submit the legal eligibility documents. The submission of technical and financial eligibility documents by any of the joint venture partners constitutes compliance, except for SSS Clearance that must be complied by all JV partners);



**I. ISSUES RAISED DURING THE PRE-BID CONFERENCE**

	Query/Clarifications	TWG/BAC Reply
1	On, 6H 5TR/6HP could it be three phase?	No, the requirement is single phase.
2	The required piping length for the project is not available on the market, the usual maximum length is 20 m only. Can the bidder modify for the requirement?	There are available products in the market that can comply with our requirements based on our market research as indicated in the brochures.
3	Is the cooling capacity on range?	Yes, as long as it can reach the maximum.
4	Are the bidders allowed to join in all the lots if they offer one brand only?	Yes.
