ANNEX A: TWG RESPONSE TO QUERIES/CLARIFICATIONS

I. ISSUES RAISED DURING PRE-BID CONFERENCE

	Query/Clarifications	SSS Reply
1	Clarification on hauling schedule	Biodegradable – daily Non-Biodegradable - Tuesday, Wednesday, Friday Recyclable -Saturday and Sunday The service provider must collect and haul garbage as scheduled, including holidays, from 5:00 p.m. to 7:00 p.m.
2	Can the bidder conduct a site inspection?	Yes, bidders may directly coordinate with the Building Administrator for the site inspection.
3	What is the required minimum capacity of the trucks?	There is no minimum capacity of the truck/s for as long as the daily maximum volume of garbage can be collected whether singly or collectively, <i>i.e.</i> regardless of the number and volume capacity of truck/s to be assigned and used by the service provider.
4	What will be the basis of daily costing, is it per trip or per kilogram?	The daily costing is based on the collection and hauling of the minimum (15 cubic meters) and maximum (18 cubic meters) volume of garbage. This amends Item 4, Section VII. Technical Specifications.

5	How much is the daily costing per trip?	P18,000.00 based on the required daily minimum and maximum volume of garbage to be collected and hauled within the prescribed collection time.
6	Is the hauling of hazardous waste included in the ABC?	No. This repeals Item No. 8, Section VII. Technical Specifications.
7	Is accreditation for hazardous hauler required?	Please refer to Item 6 above.
8	Will the daily costing increase if the bidder exceeds to one trip?	Please refer to Item 3 above.
9	If hazardous waste is not hauled, will the bidder be penalized?	Please refer to Item 6 above.

10	Hazardous waste hauling must be different from solid waste hauling as per DENR mandate.	Please refer to Item 6 above.
11	Procuring Entity must be certified Hazardous Waste Generator and has a Pollution Control Officer (PCO)	Please refer to Item 6 above.
12	Budget must be increased since during holiday seasons, more garbage are hauled.	Please refer to Item 3 above.
