- Submission and opening of 2 envelopes: **Wednesday, 11 December 2019, 2:00 p.m.** at the Bidding Room (formerly CDPRD Computer Room), 2nd Floor, SSS Main Building, East Avenue, Diliman, Quezon City

2. Documentary Requirements

a. 1st Envelope

- a.1 PhilGEPS Certificate of Registration and membership.

In case of uploaded document/s, which validity period had already expired, submit the updated document/s.

- a.2 Statement of all its Ongoing Government and Private Contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid

- a.3 Statement of Single Largest Completed Contract similar to the project to be bid within **three (3) years** prior to the submission and opening of bids equivalent to **at least 50% of the ABC**

If the bidder will participate in more than one (1) lot, the basis of the NFCC shall be the highest ABC between/among the lots the bidder intends to participate in.

- a.4 JVA, in case of Joint Venture – Class “B” Documents (Each partner of the joint venture shall submit the legal eligibility documents. The submission of technical and financial eligibility documents by any of the joint venture partners constitutes compliance)

- a.5 Omnibus Sworn Statement (form supplied)

- a.6 NFCC Computation or committed Line of Credit (**if the bidder will participate in more than one (1) lot, the basis of the NFCC shall be the highest ABC between/among the lots the bidder intends to participate in**)

- a.7 Bid Security (2% of the ABC for Cash or Manager’s/Cashier’s Check payable to SSS or Bank Draft of the ABC, 5% of the ABC for Surety Bond **or Bid Securing Declaration – form supplied**). **If the bidder opt to submit Bid Securing Declaration, it is considered applicable for all the lots. If other form of Bid Security the bidder shall submit on a per lot basis**

 - Section VII – Statement of Compliance with the Technical Specifications


c. Additional Requirements to be submitted by the bidder with the Lowest Calculated Bid

- c.1 2018 Income Tax Return filed through Electronic Filing and Payment System (EFPS) corresponding to the submitted Audited Financial Statement;
 - c.2 Quarterly VAT for the period April to September 2019;
 - c.3 Documents listed in the Platinum Membership and updates, if any;
 - SEC/DTI Registration
 - 2019 Mayor's Permit
 - Valid Tax Clearance
 - 2018 Audited Financial Statement filed through EFPS
3. Awarding shall be made to the bidder with the Lowest Calculated and Responsive Bid (LCRB) per lot.
4. All documents that need notarization should be notarized before a duly commissioned Notary Public.
5. Bidder must sign on each and every page of its Bid Proposal (Envelopes 1 & 2).


