This addendum/Bid Bulletin No. 2 is issued to clarify, modify or amend items in the Bidding Documents (BD) as a result of the pre-bidding conference on 05 August 2020. This shall form an integral part of the BD.

Under Section 22.5.3 of the RIRR of RA 9184, it shall be the responsibility of all those who have properly secured the BD to inquire and secure Supplemental/Bid Bulletins that may be issued by the BAC.

1. Schedule of activities as discussed in the Pre-bidding Conference:

- Deadline for the submission of written queries: Friday, 07 August 2020
- Issuance of Bid Bulletin No. 1 – reply to written queries: Tuesday, 11 August 2020

- **Submission and opening of 2 envelopes: Thursday, 20 August 2020, 10:00 a.m. at the 2nd Floor Bidding Room, SSS Main Building, East Avenue, Diliman, Quezon City**

Only one company representative is allowed to attend the manual opening of bids. Other company representative may witness the opening of bids through Microsoft Teams. Kindly coordinate with the BAC Secretariat for the details.

2. Documentary Requirements

a. 1st Envelope

- a.1 PhilGEPS Certificate of Registration and membership.

In case of uploaded document/s, which validity period had already expired, submit the updated document/s.

- a.2 Statement of all its Ongoing Government and Private Contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;

- a.3 Statement of Single Largest Completed Contract (SLCC) similar to the project to be bid, **with supporting documents**, equivalent to at least **50% of the ABC**, completed **within two (2) years** prior to the submission and opening of bids, adjusted by the bidder to current prices using PSA's consumer price index;

For this purpose, similar contracts shall refer to projects that includes implementation / installation / provisioning of dedicated internet services or other equivalent implementations.

- a.4 NFCC Computation or committed Line of Credit (form supplied)

- a.5 JVA, in case of Joint Venture – Class “B” Documents (Each partner of the joint venture shall submit the legal eligibility documents. The submission of technical and financial eligibility documents by any of the joint venture partners constitutes compliance, except for SSS Clearance that must be complied by all JV partners);

- a.6 Bid Security (2% of the ABC for Cash or Manager's/Cashier's Check payable to SSS or Bank Draft of the ABC, 5% of the ABC for Surety Bond **or** Bid Securing Declaration – form supplied).

c. **Additional Requirements to be submitted by the bidder with the Lowest Calculated Bid**

- c.1 2018 Income Tax Return filed through Electronic Filing and Payment System (EFPS) corresponding to the submitted Audited Financial Statement;
c.2 Quarterly VAT for the period July to December 2019 or latest available Quarterly VAT;

- c.3 Service Provider shall provide proofs (I.e. documents, certifications) that they meet the following requirement:
- c.3.1 Should be a telecommunications company or an Internet Service Provider (ISP) and has the expertise with minimum of five year experience in internet service provisioning.
 - c.3.2 Should be a telecommunications company or an ISP providing fixed internet connectivity/service to Filipino consumers or an internet service provider which has peering arrangement with all local Tier 1.
 - c.3.3 Cable facilities should at least pass through one (1) cable landing station for its international uplink.
 - c.3.4 Should have at least one (1) International POP.
 - c.3.5 Should have a network platform that is IPV4 and IPV6 ready and capable of Dual-Stacking.
 - c.3.6 Must have enough capacity to deliver the requirements and must show the IPT peering capacity of not more than 70% bandwidth utilization.
 - c.3.7 Must have an aggregate IP upstream capacity of at least 50 Gbps or more.
3. Awarding shall be made to the bidder with the Lowest Calculated and Responsive Bid (LCRB).
4. All documents that need notarization should be notarized by the Notary Public himself/herself who has the authority to do so for the current year. **A copy of the Authority to Notarize from the Notary Public must be submitted, if the document submitted is already notarized.**
5. Bidder must sign on each and every page of the Bid Proposal (1st and 2nd envelope).
