**CIRCULAR NO. 2022-028**

**TO : ALL FARMERS, FISHERMEN, AND OTHER SELF-EMPLOYED PERSONS IN THE INFORMAL ECONOMY**

**SUBJECT : PAYMENT SCHEDULE OF SOCIAL SECURITY (SS) AND EMPLOYEES' COMPENSATION (EC) CONTRIBUTIONS**

Pursuant to Sections 4 (a) (10), 19-A, and 22-A of Republic Act No. 11199 or the Social Security Act of 2018 and Social Security Commission (SSC) Resolution No. 385-s.2022 dated 8 June 2022 recognizing the unique economic, social, and geographic situation of farmers, fishermen, and other self-employed persons in the informal economy all over the Philippines, the following payment schedule is hereby issued:

- 1. Contributions for any of the last twelve (12) applicable months may be paid in the current month.**

Illustration:

<b>Payment Date</b>	<b>Applicable Months that may be paid</b>
28 Oct 2022	Oct 2021 to Sep 2022
22 Jan 2023	Jan 2022 to Dec 2022
8 May 2023	May 2022 to Apr 2023
5 Aug 2023	Aug 2022 to Jul 2023

- 2. In case the payment deadline falls on a Saturday, Sunday, or holiday, payment may be made on the next working day.**
- 3. Only contributions with payment date(s) prior to semester of contingency shall be considered in determining eligibility to benefits.**
