

CONTRACT AGREEMENT

Supply, Delivery and Installation of Air-Conditioning Units for
Various Divisions, Branches and Main Office Building
(Lot 5 - Forty-Three [43] Air-Conditioning Units for
NCR Operations Group, Divisions, Branches and Main Office Building)

THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its President and CEO, **MICHAEL G. REGINO**, duly authorized pursuant to Office Order No. 2022-026 dated 03 June 2022 (Annex "A"), hereinafter referred to as the "**SSS**";



EDGAR A. ASONIO, of legal age, Filipino, married, and duly authorized as Attorney-in-Fact pursuant to a Special Power of Attorney dated 25 April 2022 (Annex "B") executed by **MARLYN R. ASONIO**, Sole Proprietor of **HANMHE INDUSTRIAL SALES AND GENERAL SERVICES**, with office address at Maligaya Wet Market, Freeport Area of Bataan, Mariveles, Bataan, hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the SSS invited Bids for certain goods and ancillary services, particularly the **Supply, Delivery and Installation of Air-Conditioning Units for Various Divisions, Branches and Main Office Building (Lot 5 - Forty-Three [43] Air-Conditioning Units for NCR Operations Group, Divisions, Branches and Main Office Building)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: SEVEN MILLION EIGHT HUNDRED FIFTY-FIVE THOUSAND AND 00/100 (P7,855,000.00)**, Philippine currency, (hereinafter called "**the Contract Price**").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
 - a. Philippine Bidding Documents including
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
 - b. **SUPPLIER's** Bid, including –
Eligibility Requirements
 - i. PhilGEPS Registration
 - ii. Statement of Ongoing/Completed Contracts
 - iii. Omnibus Sworn Statement
Technical and Financial Proposal
 - iv. Single Largest Completed Contract



- v. Bid Security
 - vi. Net Financial Contracting Capacity
 - vii. Schedule of Requirements and Statement of Compliance
 - viii. Bid Form and Bid Breakdown
 - ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT)
- c. Performance Security
- d. Bids and Awards Committee I recommendation for Award under Resolution No. 2022-I-039-9 dated 30 June 2022 and approved on 15 July 2022, Notice of Award of Contract dated 15 July 2022 and the **SUPPLIER's** conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **PESOS: SEVEN MILLION EIGHT HUNDRED FIFTYFIVE THOUSAND AND 00/100 (P7,855,000.00)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to the Supply, Deliver and Install Forty-Three (43) Air-Conditioning Units for the NCR Operations Group Divisions, Branches and Main Office Building in accordance with its Bid.
4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding.

IN WITNESS whereof, the parties hereto have caused this **AGREEMENT** to be executed in accordance with the laws of the Republic of the Philippines on the date and place indicated in their respective Acknowledgements.




