SUPPLIER agrees that any additional contract document/s or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Agreement.

- 3. In consideration for the sum of PESOS: SEVEN MILLION FIVE HUNDRED FIFTY-SEVEN THOUSAND FOUR HUNDRED EIGHTY-SEVEN AND 20/100 (₱7,557,487.20), Philippine currency, per year, or such other sums as may be ascertained, SUPPLIER agrees to provide Security Services for the Mindanao Operations Group (Lot 2 -Mindanao West Division) for three (3) years in accordance with its Bid.
- 4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding.
