

CONTRACT AGREEMENT

Supply, Delivery, Installation and Configuration Into Operational State
of VPN Concentrator (Work from Home Access to SSS Applications)

THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its President and CEO, **MICHAEL G. REGINO**, duly authorized pursuant to Office Order No. 2022-026 dated 03 June 2022 (Annex "A"), hereinafter referred to as the "**SSS**";

TRENDS & TECHNOLOGIES, INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 6th Floor Trafalgar Plaza, 105 H.V. Dela Costa Street, Salcedo Village, Makati City, represented herein by its Account Director, **WILFREDO N. AGUILAR**, duly authorized pursuant to a Secretary's Certificate dated 24 June 2022 (Annex "B"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Supply, Delivery, Installation and Configuration into Operational State of VPN Concentrator (Work from Home Access to SSS Applications)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: SEVEN MILLION SIX HUNDRED TWENTY THOUSAND and 00/100 (P7,620,000.00)**, Philippine currency, (hereinafter called "**the Contract Price**").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:

 - b. **SUPPLIER's** Bid, including –

 - ii. Statement of Ongoing/Completed Contracts
 - iii. Omnibus Sworn Statement

Technical and Financial Proposal

- iv. Single Largest Completed Contract
 - v. Bid Security
 - vi. Net Financial Contracting Capacity
 - vii. Schedule of Requirements and Statement of Compliance
 - viii. Bid Form and Bid Breakdown
 - ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT)
- c. Performance Security
- d. BAC I recommendation for Award under Resolution No. 2022-I-051-6 dated 16 August 2022, approved on 26 August 2022; Notice of Award of Contract dated 26 August 2022 and the **SUPPLIER's** conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **PESOS: SEVEN MILLION SIX HUNDRED TWENTY THOUSAND and 00/100 (P7,620,000.00)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to the Supply, Deliver, Install and Configure into Operational State the VPN Concentrator (Work From Home Access to SSS Applications) in accordance with its Bid.
4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding.
