

CONTRACT AGREEMENT

THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Authorized Signatory and Vice President for Procurement Management Division, **DORENDA M. DASMARIÑAS**, duly authorized pursuant to Office Order No. 2022-026-b dated 16 December 2022, (Annex "A"), hereinafter referred to as the "**SSS**";

SUMMIT FURNISHINGS, INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 2634 Rockefeller St., Brgy. San Isidro, Makati City, represented herein by its Key Account Manager, **MARITA V. UMIPIG**, duly authorized pursuant to a Secretary's Certificate dated 10 October 2022 (Annex "B"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Modular Furniture of SSS Sorsogon Branch** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: SEVEN HUNDRED NINETY-EIGHT THOUSAND FOUR HUNDRED TWELVE AND 16/100 (P798,412.16)**, Philippine currency, (hereinafter called "the Contract Price").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:

 - vii. Schedule of Requirements and Statement of Compliance
 - viii. Bid Form and Bid Breakdown
 - ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT).

In consideration for the sum of **PESOS: SEVEN HUNDRED NINETY-EIGHT THOUSAND FOUR HUNDRED TWELVE AND 16/100 (₱798,412.16)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to supply, deliver and install modular furniture for SSS Sorsogon Branch in accordance with its Bid.
 4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
