

CONTRACT AGREEMENT
REPLACEMENT OF VACUUM CIRCUIT BREAKER (VCB) NO. 1 & 2
AT POWER SUBSTATION 1
ITB-SSS-Goods-2022-082

THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Approving Authority and Senior Vice President for Member Services and Support Group, **NORMITA M. DOCTOR**, and its Vice President and Acting Head for Administration Group, **DORENDA M. DASMARIÑAS**, duly authorized pursuant to Administrative Order No. 2022-089 dated 16 November 2022 (Annex "A") and Office Order No. 2022-026-b dated 16 December 2022 (Annex "B"), hereinafter referred to as the "**SSS**";

T & D POWER SYSTEMS CORPORATION, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at #35 Josefina Subdivision, Barangay Mambugan, Sumulong Highway, Antipolo City, represented herein by its Project Engineer, **ARNEL L. RAMOS, JR.**, duly authorized pursuant to a Secretary's Certificate dated 08 November 2022 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Replacement of Vacuum Circuit Breaker (VCB) No. 1 & 2 at Power Substation 1** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: SEVEN MILLION THREE HUNDRED SIXTY-TWO THOUSAND SEVEN HUNDRED FIFTY-FOUR AND 56/100 (P7,362,754.56)**, Philippine currency, (hereinafter called "the Contract Price").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
 - a. Philippine Bidding Documents including
 - i. Schedule of Requirements;
 - ii. Technical Specifications
 - iii. General; and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
 - b. **SUPPLIER's** Bid, including –
 - Eligibility Requirements
 - i. Philgeps Registration;
 - ii. Statement of Ongoing/Completed Contracts
 - iii. Omnibus Sworn Statement
 - Technical and Financial Proposals
 - iv. Single Largest Completed Contract
 - v. Bid Security
 - vi. Net Financial Contracting Capacity

- vii. Schedule of Requirements and Statement of Compliance
- viii. Bid Form and Bid Breakdown
- ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT).

- c. Performance Security
- d. BAC I Recommendation for Award under Resolution No. 2022-I-078-4 dated 24 November 2022, approved on 02 December 2022; Notice of Award of Contract dated 02 December 2022 and the **SUPPLIER's** conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **PESOS: SEVEN MILLION THREE HUNDRED SIXTY-TWO THOUSAND SEVEN HUNDRED FIFTY-FOUR AND 56/100 (₱7,362,754.56)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to replace the Vacuum Circuit Breaker (VCB) No. 1 & 2 at Power Substation 1 in accordance with its Bid.
4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof, the parties hereto have caused this **AGREEMENT** to be executed in accordance with the laws of the Republic of the Philippines on the date and place indicated in their respective acknowledgments.
