

CONTRACT AGREEMENT
THREE (3) YEAR MAINTENANCE SERVICES OF NETWORK EQUIPMENT
ITB-SSS-Goods-2023-006

THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Executive Vice President and Head, Investments Sector, **RIZALDY T. CAPULONG**, and Vice President for Program Services Division and Concurrent Acting Head for Information Technology Management Group, **GWEN MARIE JUDY D. SAMONTINA**, duly authorized pursuant to Administrative Order No. 2023-009-b dated 18 April 2023 (Annex "A") and Office Order No. 2022-026-b dated 16 December 2022 (Annex "B"), hereinafter referred to as the "**SSS**";

TRENDS & TECHNOLOGIES, INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 6th Floor, Trafalgar Plaza, 105 H.V. Dela Costa Street, Salcedo Village, Makati City, represented herein by its Account Director, **WILFREDO N. AGUILAR**, and Sales Assistants, **LEAH P. APOSTOL** and **DARLENE A. SADSAD**, duly authorized pursuant to a Secretary's Certificate dated 02 March 2023 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Three (3) Year Maintenance Services of Network Equipment** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: FIVE MILLION FIVE HUNDRED FIFTEEN THOUSAND AND 00/100 (P5,515,000.00)**, Philippine currency, for the first year, or a total of **PESOS: ELEVEN MILLION TWO HUNDRED THIRTY-SEVEN THOUSAND AND 00/100 (P11,237,000.00)**, Philippine currency, for three (3) years, (hereinafter called "the Contract Price").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:

- a. Philippine Bidding Documents including
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General; and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.

- b. **SUPPLIER's** Bid, including –

Eligibility Requirements


- i. Philgeps Registration;
- ii. Statement of Ongoing/Completed Contracts;
- iii. Omnibus Sworn Statement.

Technical and Financial Proposals


- iv. Single Largest Completed Contract;
- v. Bid Security;

- vi. Net Financial Contracting Capacity;
 - vii. Schedule of Requirements and Statement of Compliance;
 - viii. Bid Form and Bid Breakdown;
 - ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT).
- c. Performance Security;
 - d. BAC I Recommendation for Award under Resolution No. 2023-I-028-10 dated 20 April 2023, approved on 27 April 2023; Notice of Award of Contract dated 27 April 2023 and the **SUPPLIER's** conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **PESOS: FIVE MILLION FIVE HUNDRED FIFTEEN THOUSAND AND 00/100 (P5,515,000.00)**, Philippine currency, for the first year, or a total of **PESOS: ELEVEN MILLION TWO HUNDRED THIRTY-SEVEN THOUSAND AND 00/100 (P11,237,000.00)**, Philippine currency, for three (3) years, or such other sums as may be ascertained, **SUPPLIER** agrees to provide Maintenance Services of the Network Equipment for three (3) years in accordance with its bid.
4. The **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding
