

CONTRACT AGREEMENT
BULK PURCHASE OF SUPPLIES AND MATERIALS FOR CY 2023
[LOT 2 – IT SUPPLIES (RIBBONS, TONER AND LTO ULTRIUM)]

THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Approving Authority and Executive Vice President for Investments Sector, **RIZALDY T. CAPULONG**, and its Vice President and Concurrent Acting Head for Administration Group, **DORENDA M. DASMARIÑAS-PAN**, duly authorized pursuant to Administrative Order No. 2023-009-b dated 18 April 2023 (Annex "A") and Office Order No. 2023-020 dated 05 April 2023 (Annex "B"), hereinafter referred to as the "**SSS**";

FASTLINE TRADING INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at Unit 207, 2F Victoria de Makati, Washington corner Dela Rosa St., Pio Del Pilar, Makati City, represented herein by its President, **SAMUEL G. MADDUMA**, duly authorized pursuant to a Secretary's Certificate dated 15 March 2023 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Bulk Purchase of Supplies and Materials for CY 2023 [Lot 2 – IT Supplies (Ribbons, Toner and LTO Ultrium)]** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: SEVEN MILLION SEVEN HUNDRED THIRTY-FOUR THOUSAND SIX HUNDRED NINETY-FIVE AND 00/100 (₱7,734,695.00)**, Philippine currency, (hereinafter called "the Contract Price").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
 - a. Philippine Bidding Documents including
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General; and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
 - b. **SUPPLIER's** Bid, including the Eligibility requirements. Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the **SUPPLIER's** bidding envelopes, as annexes, and all other documents submitted (e.g. **SUPPLIER's** response to request for clarifications on the bid), including corrections to the bid, if any, resulting from **SSS'** bid evaluation;
 - c. Performance Security;
 - d. BAC I Recommendation for Award under Resolution No. 2023-I-032-1 dated 08 May 2023, approved on 16 May 2023; Notice of Award


of Contract dated 16 May 2023 and the **SUPPLIER's** conforme thereto; and

- e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**


- 3. In consideration for the sum of **PESOS: SEVEN MILLION SEVEN HUNDRED THIRTY-FOUR THOUSAND SIX HUNDRED NINETY-FIVE AND 00/100 (P7,734,695.00)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to provide supplies and materials for CY 2023 particularly IT Supplies (Ribbons, Toner and LTO Ultrium) in accordance with its bid.

- 4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding


