

CONTRACT AGREEMENT
SERVICING OF POWER SUBSTATION 1 AND 2
ITB-SSS-Goods-2023-016

THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Approving Authority and Executive Vice President for Investments Sector, **RIZALDY T. CAPULONG**, and its Vice President for Procurement Management Division and Concurrent Acting Head for Administration Group, **DORENDA M. DASMARIÑAS**, duly authorized pursuant to Administrative Order No. 2023-009-b dated 18 April 2023 (Annex "A") and Office Order No. 2022-026-b dated 16 December 2022 (Annex "B"), hereinafter referred to as the "**SSS**";

T&D POWER SYSTEMS CORPORATION, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at #35 Josefina Subdivision, Barangay Mambugan, Antipolo City represented herein by its Project Engineer, **ARNEL L. RAMOS, JR.** duly authorized pursuant to a Secretary's Certificate dated 19 April 2023 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Servicing of Power Substation 1 & 2** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: THREE MILLION FIVE HUNDRED THOUSAND (₱3,500,000.00)**, Philippine currency, (hereinafter called "the Contract Price").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:



- c. Performance Security;
 - d. BAC II Recommendation for Award under Resolution No. 2023-II-043-12 dated 24 May 2023, approved on 02 June 2023; Notice of Award of Contract dated 02 June 2023 and the **SUPPLIER's** conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **PESOS: THREE MILLION FIVE HUNDRED THOUSAND (P3,500,000.00)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to provide servicing for the Power Substations 1 and 2 in accordance with its bid.
4. The **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding
