THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Authorized Signatories, Senior Vice President for Lending and Asset Management Group, **PEDRO T. BAOY**, and Vice President for Procurement Management Division and Concurrent Acting Head for Administration Group, **DOREDA M. DASMARIÑAS**, duly authorized pursuant to Office Order No. 2023-032 dated 23 August 2023 (Annex "A") and Administrative Order No. 2023-009-c dated 19 July 2023 (Annex "B") and, hereinafter referred to as the "**SSS**";

BITSOFT TECHNOLOGY CO. a partnership duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 89-B Narra Street, Barangay Amihan, Project 3, Quezon City, represented herein by its Business Development Manager, **DAISY R. REYNOSO**, duly authorized pursuant to Omnibus Sworn Statement dated 14 June 2023 (Annex "C") and Partnership Resolution dated 14 June 2023 (Annex "D"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Procurement of Various Semi-Expendable Equipment for CY2023 [Lot 1: Office Equipment]** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: THREE MILLION ONE HUNDRED NINETEEN THOUSAND ONE HUNDRED SIXTY-ONE AND 00/100 (₱3,119,161.00)**, Philippine currency, (hereinafter called "the Contract Price").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:


1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:

 - iii. Omnibus Sworn Statement.
 - Technical and Financial Proposals
 - iv. Single Largest Completed Contract;
 - v. Bid Security;
 - vi. Net Financial Contracting Capacity;


- vii. Schedule of Requirements and Statement of Compliance;
 - viii. Bid Form and Bid Breakdown;
 - ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT).
- c. Performance Security;
 - d. BAC I Recommendation for Award under Resolution No. 2023-I-052-3 dated 04 August 2023, approved on 11 August 2023; Notice of Award of Contract dated 11 August 2023 and the **SUPPLIER's** conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of PESOS: THREE MILLION ONE HUNDRED NINETEEN THOUSAND ONE HUNDRED SIXTY-ONE AND 00/100 (P3,119,161.00), Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to provide various semi-expendable equipment for CY2023 particularly office equipment in accordance with its bid.
 4. The **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding
