THIS **AGREEMENT** made between:

**SOCIAL SECURITY SYSTEM**, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Authorized Signatory and Vice President for Procurement Management Division, **DORENDA M. DASMARIÑAS**, duly authorized pursuant to Office Order No. 2022-026-b dated 16 December 2022 (Annex "A"), hereinafter referred to as the "**SSS**";

**SECURITY BANK CORPORATION – TRUST AND ASSET MANAGEMENT GROUP**, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 7<sup>th</sup> Floor, Security Bank Centre, 6776 Ayala Avenue, Makati City, represented herein by its Senior Assistant Vice President, **MARIE CARMELA T. LIM** and its Senior Manager, **ANGELA CHRISTINA C. ENCARNACION**, duly authorized pursuant to a Secretary's Certificate, dated 22 June 2022 (Annex "B"), hereinafter referred to as the "**CONSULTANT**".

WHEREAS, the **SSS** is desirous that the **CONSULTANT** execute the contract for the **Hiring of Nine (9) Local Fund Managers [Lot II – Balanced Fund Mandate]** (hereinafter called the "Works") and the **SSS** has accepted the bid for a management fee of equivalent to **0.10% per annum computed based on the quarterly average market value of the fund managed, not to exceed PESOS: ONE MILLION FIVE HUNDRED THOUSAND (₱1,500,000.00)**, Philippine currency, per year or a total amount of **PESOS: FOUR MILLION FIVE HUNDRED THOUSAND (₱4,500,000.00)**, Philippine currency, for three years by the **CONSULTANT** for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

  - (i) Performance security;
  - (j) BAC II Recommendation for Award under Resolution No. 2022-II-085-2 dated 23 December 2022, approved on 28 December 2022; Notice of Award of Contract dated 28 December 2022 and the **CONSULTANT's** conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the SSS.
3. In consideration of the payments to be made by the **SSS** to the **CONSULTANT** as hereinafter mentioned, the **CONSULTANT** hereby covenants with the SSS to execute and complete the Works/Consulting Services and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The **SSS** hereby covenants to pay the **CONSULTANT** in consideration of the execution and completion of the Works/Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


