PROPOSED LEGAL OFFICE AT SSS PAMPANGA BRANCH AND PROPOSED RETILING OF
MSS WAITING AREA AND STAIRCASE AT SSS DAU BRANCH

THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Authorized Signatory and Vice President for Procurement Management Division, **DORENDA M. DASMARIÑAS**, duly authorized pursuant to Office Order No. 2022-026 dated 03 June 2022 (Annex "A"), hereinafter referred to as the "**SSS**";

GOLDBERN CONSTRUCTION CORPORATION, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at #2 Paladium Street Goldendale Subdivision, Tinajeros, Malabon City, represented herein by its President, **MANUEL S. BERNARDO JR.**, duly authorized pursuant to a Secretary's Certificate dated 10 October 2022 (Annex "B"), hereinafter referred to as the "**CONTRACTOR**".

WHEREAS, the **SSS** is desirous that the **CONTRACTOR** execute the **Proposed Legal Office at SSS Pampanga Branch and Proposed Retiling of MSS Waiting Area and Staircase at SSS Dau Branch** (hereinafter called "the Works") and the **SSS** has accepted the Bid by the **CONTRACTOR** for the supply of those goods and services in the sum of **PESOS: EIGHT HUNDRED FIFTY THOUSAND AND 34/100 (P850,000.34)**, Philippine currency, by the **CONTRACTOR** for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:


- a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
- b. **CONTRACTOR's** bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the **CONTRACTOR's** bidding envelopes, as annexes, and all other documents submitted (e.g., **CONTRACTOR's** response to request for clarifications on the bid), including corrections to the bid, if any, resulting from **SSS'** bid evaluation;

- c. Performance Security;

- d. BAC II Recommendation for Award under Resolution No. 2022-II-069-9 dated 16 November 2022, approved on 29 November 2022; Notice of Award of Contract dated 29 November 2022 and the **CONTRACTOR's** conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **CONTRACTOR agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **PESOS: EIGHT HUNDRED FIFTY THOUSAND AND 34/100 (₱850,000.34)**, Philippine currency, or such other sums as may be ascertained, **CONTRACTOR** agrees to renovate the proposed Legal Office at SSS Pampanga Branch and retile the MSS Waiting Area and Staircase at SSS Dau Branch in accordance with its Bid.
 4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




