

CONTRACT AGREEMENT
ISSUANCE OF GENERIC UMID CARDS TO MEMBERS
ITB-SSS-Goods-2022-033

THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its President and CEO, **MICHAEL G. REGINO**, duly authorized pursuant to Office Order No. 2022-026 dated 03 June 2022 (Annex "A"), hereinafter referred to as the "**SSS**";

ALLCARD INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at Lot 3 Block 17 E. Rodriguez Jr. Ave. corner Titan Street, Acropolis Subdivision, Bagumbayan, Quezon City, represented herein by its VP Sales Manager, **CARLO ENRICO Y. JARLEGO**, and its Sales Manager, **FELIPE R. ILLUT**, duly authorized per its Secretary's Certificate dated 01 June 2022 (Annex "B"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Issuance of Generic UMID Cards to Members** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: SEVENTY EIGHT MILLION SEVEN HUNDRED THIRTY NINE THOUSAND TWO HUNDRED AND 00/100 (₱78,739,200.00)** Philippine currency, (hereinafter called "**the Contract Price**").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT**, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
 - b. **SUPPLIER's** Bid, including –
Eligibility Requirements
 - i. PhilGEPS Registration
 - ii. Statement of Ongoing/Completed Contracts
 - iii. Omnibus Sworn Statement

Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **PESOS: SEVENTY EIGHT MILLION SEVEN HUNDRED THIRTY NINE THOUSAND TWO HUNDRED AND 00/100 (P78,739,200.00)** Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to provide the Issuance of Generic UMID Cards to Members in accordance with its Bid.
4. SSS agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding.
