

CONTRACT AGREEMENT

THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Authorized Signatory and Vice President for Procurement Management Division, **DORENDA M. DASMARIÑAS**, duly authorized pursuant to Office Order No. 2022-026 dated 03 June 2022 (Annex "A"), hereinafter referred to as the "**SSS**";

DEPENDABLE PACKAGING AND PRINTING HOUSE CORPORATION, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 70 S. Donesa St., Canumay West, Valenzuela City, represented herein by its Authorized Representative, **ROWENA G. ACUÑA**, duly authorized pursuant to a Secretary's Certificate dated 02 August 2022 (Annex "B"), hereinafter referred to as the "**SUPPLIER**".


WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Printing of SSS Information Materials for CY 2022** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **ONE MILLION ONE HUNDRED SEVENTY-SIX THOUSAND ONE HUNDRED FIFTY PESOS (P1,176,150.00)** (hereinafter called "the Contract Price").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
 - a. Philippine Bidding Documents including
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
 - b. **SUPPLIER's** Bid, including –
 - Eligibility Requirements
 - i. PhilGEPS Registration
 - ii. Statement of Ongoing/Completed Contracts
 - iii. Omnibus Sworn Statement
 - Technical and Financial Proposal
 - iv. Single Largest Completed Contract
 - v. Bid Security
 - vi. Net Financial Contracting Capacity
 - vii. Schedule of Requirements and Statement of Compliance
 - viii. Bid Form and Bid Breakdown
 - ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT)

- c. Performance Security
 - d. BAC II Recommendation for Award under Resolution No. 2022-II-051-13 dated 31 August 2022, approved on 15 September 2022; Notice of Award of Contract dated 15 September 2022 and the **SUPPLIER's** conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **ONE MILLION ONE HUNDRED SEVENTY-SIX THOUSAND ONE HUNDRED FIFTY PESOS (₱1,176,150.00)** or such other sums as may be ascertained, **SUPPLIER** agrees to provide the Printing of SSS Information Materials for CY 2022 in accordance with its Bid.
 4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




