SUBSCRIPTION OF 3X400 MBPS CORPORATE INTERNET ACCESS FOR MAIN OFFICE
AND DISASTER RECOVERY (DR) SITE FOR THREE (3) YEARS [LOT 1]

THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Vice President for Human Resource Services Division and Acting Head for Human Resource Management Group, **MA. NYMPHA M. RAGEL**, and Vice President for Program Services Division and Acting Head for Information Technology Management Group, **ALAN GENE O. PADILLA**, duly authorized pursuant to Administrative Order No. 2022-032 dated 21 April 2022 (Annex "A") and Office Order No. 2022-026 dated 03 June 2022 (Annex "B"), hereinafter referred to as the "SSS";

CONVERGE INFORMATION AND COMMUNICATIONS TECHNOLOGY SOLUTIONS, INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at New Street Bldg., Mc Arthur Highway, Balibago, Angeles City, Pampanga, represented herein by its Chief Operations Officer, **JESUS C. ROMERO**, duly authorized pursuant to a Secretary's Certificate dated 25 August 2022 (Annex "C"), hereinafter referred to as the "SUPPLIER".

WHEREAS, the SSS invited Bids for certain goods and ancillary services, particularly the **Subscription of 3X400 Mbps Corporate Internet Access for Main Office and Disaster Recovery (DR) Site for Three (3) Years [Lot 1]** and has accepted a Bid by the SUPPLIER for the supply of those goods and services in the sum of **PESOS: TWO MILLION ONE HUNDRED FORTY-THREE THOUSAND TWO HUNDRED (P2,143,200.00)**, Philippine Currency, per year or a total of **PESOS: SIX MILLION FOUR HUNDRED TWENTY-NINE THOUSAND SIX HUNDRED (6,429,600.00)**, Philippine Currency, for three (3) years (hereinafter called "the Contract Price").


NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this AGREEMENT words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this AGREEMENT, viz.:
 - a. Philippine Bidding Documents including
 - i. Schedule of Requirements;
 - ii. Technical Specifications
 - iii. General; and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
 - b. SUPPLIER's Bid, including --
 - Eligibility Requirements
 - i. Philgeps Registration;
 - ii. Statement of Ongoing/Completed Contracts
 - iii. Omnibus Sworn Statement

 - v. Bid Security
 - vi. Net Financial Contracting Capacity
 - vii. Schedule of Requirements and Statement of Compliance

 - ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT).

- d. BAC I Recommendation for Award under Resolution No. 2022-I-068-6 dated 13 October 2022, approved on 28 October 2022; Notice of Award of Contract dated 28 October 2022 and the **SUPPLIER's** conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **PESOS: TWO MILLION ONE HUNDRED FORTY-THREE THOUSAND TWO HUNDRED (P2,143,200.00)**, Philippine Currency, per year or a total of **PESOS: SIX MILLION FOUR HUNDRED TWENTY-NINE THOUSAND SIX HUNDRED (6,429,600.00)**, Philippine Currency, for 3 years or such other sums as may be ascertained, **SUPPLIER** agrees to provide 400 Mbps Primary Corporate Internet Access for Main Office and DR Site for 3 years in accordance with its Bid.
4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
