

**CONTRACT AGREEMENT**  
**THREE (3) YEAR SUBSCRIPTION OF SYSTEM VULNERABILITY SCANNER**  
**ITB-SSS-Goods-2022-085**

THIS AGREEMENT made between:

**SOCIAL SECURITY SYSTEM**, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Approving Authority and Senior Vice President for Member Services and Support Group, **NORMITA M. DOCTOR**, and its Vice President and Acting Head for Information Technology Management Group, **ALAN GENE O. PADILLA**, duly authorized pursuant to Administrative Order No. 2022-089 dated 16 November 2022 (Annex "A") and Office Order No. 2022-026-b dated 16 December 2022 (Annex "B"), hereinafter referred to as the "**SSS**";

**NEXT GENERATION TECHNOLOGIES GLOBAL, INC.**, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 4<sup>th</sup> Floor Mother of Unity Building, 118 JP Rizal corner E. dela Paz Streets, San Roque, Marikina City, represented herein by its Sr. Account Manager, **THRECIA ESTROPIGAN**, duly authorized pursuant to a Secretary's Certificate dated 07 November 2022 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Three (3) Year Subscription of System Vulnerability Scanner** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: SEVEN MILLION TWO HUNDRED NINETY-NINE THOUSAND NINE HUNDRED NINETY-NINE (₱7,299,999.00)** Philippine currency, (hereinafter called "the Contract Price").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:

Technical and Financial Proposals
    - iv. Single Largest Completed Contract
    - v. Bid Security
    - vi. Net Financial Contracting Capacity
    - vii. Schedule of Requirements and Statement of Compliance

viii. Bid Form and Bid Breakdown

ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT).

- d. BAC I Recommendation for Award under Resolution No. 2022-I-084-3 dated 14 December 2022, approved on 28 December 2022; Notice of Award of Contract dated 28 December 2022 and the **SUPPLIER's** conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

- 3. In consideration for the sum of **PESOS: SEVEN MILLION TWO HUNDRED NINETY-NINE THOUSAND NINE HUNDRED NINETY-NINE (₱7,299,999.00)** Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to provide the System Vulnerability Scanner for Three (3) years in accordance with its Bid.
- 4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
