

## CONTRACT AGREEMENT

Supply, Delivery and Installation of 2 Sets 200 KVA Modular Uninterruptible Power Supply (UPS) with Batteries, Transformers, and Electrical Works, with a 2-Year Warranty and 5-Year Comprehensive Preventive Maintenance Services (CPMS)  
RFQ 2022-9-007 dated 23 September 2022

THIS AGREEMENT made between:

**SOCIAL SECURITY SYSTEM**, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its President and CEO, **MICHAEL G. REGINO**, duly authorized pursuant to Office Order No. 2022-026 dated 03 June 2022 (Annex "A"), hereinafter referred to as the "**SSS**";




The **JOINT VENTURE** of **GLOBAL TRENDS & INFRASTRUCTURE TECHNOLOGIES INC. (GLOBAL TRENDS)**, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at CTF Tower #34 San Rafael St., Brgy. Plainview, Mandaluyong City, and **T & D POWER SYSTEMS CORPORATION (T & D)**, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 35 Josefina Subdivision, Brgy. Mambugan, Antipolo City, represented herein by the Senior Sales Manager of **GLOBAL TRENDS, ABEGAELA. ALVIAR**, duly authorized pursuant to Article I, Section 5 of the Joint Venture Agreement dated 26 September 2022 and Secretary's Certificate of **GLOBAL TRENDS** dated 26 September 2022 (Annexes "B" and "C", respectively), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** sent requests for quotation for certain goods and ancillary services, particularly the **Emergency Procurement of Uninterruptible Power Supply (UPS) and Related Items and Works (PROJECT)** and has accepted the offer by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: FORTY-THREE MILLION TWO HUNDRED THOUSAND and 00/100 (₱43,200,000.00)**, Philippine currency, (hereinafter called "**the Contract Price**").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
  - a. Request for Quotation (RFQ)
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract;
    - iv. Supplemental or Bid Bulletins, if any, when applicable;
    - v. Confirmation of Negotiated items, when applicable.
  - b. Supplier's offer, including the Eligibility requirements, Technical and



Financial Proposals, and all other documents or statements submitted;

Supplier's Offer/Quotation, including all the documents/statements contained in the Supplier's offer/quotation -, as annexes, and all other documents submitted (e.g., Supplier's response to request for clarifications on the offer), including corrections to the offer, if any, resulting from SSS' bid evaluation;

- c. Performance Security;
  - d. BAC I Recommendation for Award under Resolution No. 2022-I-065-1 dated 04 October 2022, approved on 04 October 2022; Notice of Award of Contract dated 10 October 2022 and the Supplier's conforme thereto; and
  - e. Other contract documents that may be required by existing laws and/or the SSS concerned in the RFQ. Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **PESOS: FORTY-THREE MILLION TWO HUNDRED THOUSAND and 00/100 (P43,200,000.00)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to provide the Uninterruptible Power Supply (UPS) and Related Items and Works in accordance with its Offer.
4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the RFQ.

IN WITNESS whereof, the parties hereto have caused this **AGREEMENT** to be executed in accordance with the laws of the Republic of the Philippines on the date and place indicated in their respective Acknowledgements.




