

CONTRACT AGREEMENT

Three (3) Year Contract for Security Services: Mindanao Operations Group
(Lot 1 – Mindanao North Division)
ITB-SSS-Goods-2022-036

THIS AGREEMENT made by and between:

SOCIAL SECURITY SYSTEM, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, otherwise known as the Social Security Act of 2018, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its President and CEO, **MICHAEL G. REGINO**, duly authorized pursuant to Office Order No. 2022-026 dated 03 June 2022 (Annex "A"), hereinafter referred to as the "**SSS**";

MBG SECURITY & INVESTIGATION SERVICES, INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 2/F MBG Building, Matina Pangli Road, Barangay Matina Pangli, Davao City, represented herein by its General Manager, **SIXTO D. JIMENEZ III**, duly authorized pursuant to a Secretary's Certificate dated JUN 10 2022 (Annex "B"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Three (3) Year Contract for Security Services: Mindanao Operations Group (Lot 1 – Mindanao North Division)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: TWENTY-ONE MILLION NINE HUNDRED FORTY THOUSAND NINE HUNDRED NINETY-SEVEN AND 20/100 (₱21,940,997.20)**, Philippine currency, per year (hereinafter called "the Contract Price").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
 - a. Philippine Bidding Documents including
 - i. Schedule of Requirements;
 - ii. Technical Specifications
 - iii. General; and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
 - b. **SUPPLIER's** Bid, including –

Eligibility Requirements

 - i. Philgeps Registration;
 - ii. Statement of Ongoing/Completed Contracts;
 - iii. Omnibus Sworn Statement

Technical and Financial Proposals

 - iv. Single Largest Completed Contract;
 - v. Bid Security;
 - vi. Net Financial Contracting Capacity;
 - vii. Schedule of Requirements and Statement of Compliance;
 - viii. Bid From and Bid Breakdown;

- ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT).
- c. Performance Security
- d. SSC Resolution No. 568-s.2022 dated 22 August 2022 approving the Recommendation for Award; Notice of Award of Contract dated 19 September 2022 and the **SUPPLIER's** conforme thereto with letter of clarification of the Notice of Award dated 10 October 2022; and
- e. Other contract documents that may be required by existing laws and/or the SSS –
 - i. Contribution Collection List;
 - ii. License to Operate;
 - iii. List of Equipment & Devices;
 - iv. List of Trainings; and
 - v. Security Plan.

SUPPLIER agrees that any additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Agreement.

- 3. In consideration for the sum of **PESOS: TWENTY-ONE MILLION NINE HUNDRED FORTY THOUSAND NINE HUNDRED NINETY-SEVEN AND 20/100 (P21,940,997.20)**, Philippine currency, per year, or such other sums as may be ascertained, **SUPPLIER** agrees to provide Security Services for Mindanao North Division for three (3) years in accordance with its Bid.
- 4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding.

IN WITNESS whereof, the parties hereto have caused this **AGREEMENT** to be executed in accordance with the laws of the Republic of the Philippines on the date and place indicated in their respective Acknowledgements.


