THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Approving Authority and Senior Vice President for Lending and Asset Management Group, **PEDRO T. BAOY**, and Acting Head for General Services Division, **WENDELINO V. COMBOY, JR.**, duly authorized pursuant to Administrative Order No. 2023-009-c dated 19 July 2023 (Annex "A") and Office Order No. 2023-032 dated 23 August 2023 (Annex "B"), hereinafter referred to as the "SSS";

PETRON CORPORATION, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at SMC Head Office Complex, No. 40 San Miguel Avenue, Mandaluyong City represented herein by its Vice President for Retail Sales, **MAGNOLIA CECILIA D. UY**, and Manager for Cards Business Group, **ALVIN CHRISTOPHER J. BECINA**, duly authorized pursuant to a Secretary's Certificate dated 02 October 2023 (Annex "C"), hereinafter referred to as the "SUPPLIER".

WHEREAS, the SSS invited Bids for certain goods and ancillary services, particularly the **Fleet Card Program for Fuels for the Main Office Service Vehicles (4th Advertisement)** and has accepted a Bid by the SUPPLIER for the supply of those goods and services in the sum of **PESOS: TWENTY-SEVEN MILLION THREE HUNDRED TEN THOUSAND SEVEN HUNDRED FIFTY-FIVE AND 52/100 (₱27,310,755.52)**, Philippine currency (hereinafter called "the Contract Price").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this AGREEMENT words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this AGREEMENT, viz.:

 - iii. Omnibus Sworn Statement.

In consideration for the sum of **PESOS: TWENTY-SEVEN MILLION THREE HUNDRED TEN THOUSAND SEVEN HUNDRED FIFTY-FIVE AND 52/100 (P27,310,755.52)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to provide Fleet Card Services for the Main Office Service Vehicles in accordance with its bid.
4. The **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding
