THREE (3) YEAR CONTRACT FOR SECURITY SERVICES:

THIS **AGREEMENT** made between:

SOCIAL SECURITY SYSTEM, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, otherwise known as the Social Security Act of 2018, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its President and CEO, **MICHAEL G. REGINO**, duly authorized pursuant to Office Order No. 2022-026 dated 03 June 2022 (Annex "A"), hereinafter referred to as the "**SSS**";

JAMILA AND COMPANY SECURITY SERVICES, INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 81-JCI Corporate Centre, Lantana Street, Cubao, Quezon City, represented herein by President, **SERGIO O. JAMILA III**, duly authorized pursuant to Secretary's Certificate dated 21 June 2022 (Annex "B"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Three (3) Year Contract for Security Services of the Mindanao Operations Group [Lot 4: Mindanao South 2 Division] (PROJECT)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: NINE MILLION ONE HUNDRED NINETY-ONE THOUSAND NINE HUNDRED FORTY-THREE AND 60/100 (₱9,191,943.60)**, Philippine currency, per year (hereinafter called "the Contract Price").

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents, as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184, shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:
 - a. Philippine Bidding Documents including
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General; and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any.
 - b. **SUPPLIER's** Bid, including –
 - Eligibility Requirements
 - i. Philgeps Registration;
 - ii. Statement of Ongoing/Completed Contracts;
 - iii. Omnibus Sworn Statement.
 - Technical and Financial Proposals
 - iv. Single Largest Completed Contract;
 - v. Bid Security;
 - vi. Net Financial Contracting Capacity;
 - vii. Schedule of Requirements and Statement of Compliance;
 - viii. Bid Form and Bid Breakdown;

- ix. Additional Documents (SEC Registration, Mayor's Permit, Audited Financial Statement, Income Tax Return, Tax Clearance, Quarterly VAT).
- c. Performance Security
- d. BAC I Recommendation for Award under Resolution No. 2022-I-050-3 dated 15 August 2022, approved on 26 August 2022; Notice of Award of Contract dated 26 August 2022 and the **SUPPLIER's** conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the SSS –
 - i. License to Operate;
 - ii. List of Equipment & Devices;
 - iii. List of Trainings;
 - iv. Security Plan.

SUPPLIER agrees that any additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of this Agreement.

- 3. In consideration for the sum of **PESOS: NINE MILLION ONE HUNDRED NINETY-ONE THOUSAND NINE HUNDRED FORTY-THREE AND 60/100 (P9,191,943.60)** Philippine currency, per year or such other sums as may be ascertained, **SUPPLIER** agrees to provide Security Services for Mindanao South 2 Division for three (3) years in accordance with its Bid.
- 4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding.


IN WITNESS whereof, the parties hereto have caused this **AGREEMENT** to be executed in accordance with the laws of the Republic of the Philippines on the date and place indicated in their respective Acknowledgements.
