DASMARIÑAS**, duly authorized pursuant to Office Order No. 2022-026 dated 03 June 2022 (Annex "A"), hereinafter referred to as the "**SSS**";

SOCOTEC CERTIFICATION PHILIPPINES, INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 2F JD Tower, Commerce Avenue, Madrigal Business Park, Ayala Alabang, Muntinlupa, represented herein by its Operations Director, **GILMORE A. RIVERA**, duly authorized pursuant to a Secretary's Certificate dated 05 October 2022 (Annex "B"), hereinafter referred to as the "**CONSULTANT**".


WHEREAS, the **SSS** is desirous that the **CONSULTANT** execute the contract for the **Hiring of ISO 9001:2015 Certification Body for Unemployment Benefit Process QMS** (hereinafter called the "Works") and the **SSS** has accepted the bid for **PESOS: SIX HUNDRED FOUR THOUSAND EIGHT HUNDRED PESOS (P604,800.00)**, Philippine currency, by the **CONSULTANT** for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW, THIS **AGREEMENT** WITNESSETH AS FOLLOWS:

 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid forms, including all the documents/statements contained in the Consultant's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., Consultant's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the SSS' bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Approval of Recommendation for Award dated 16 November 2022; Notice of Award of Contract dated 25 November 2022 and the **CONSULTANT'S** conforme thereto;

- (k) Other contract documents that may be required by existing laws and/or the SSS.
3. In consideration of the payments to be made by the **SSS** to the **CONSULTANT** as hereinafter mentioned, the **CONSULTANT** hereby covenants with the SSS to execute and complete the Works/Consulting Services and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The **SSS** hereby covenants to pay the **CONSULTANT** in consideration of the execution and completion of the Works/Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


