THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Senior Vice President for Lending and Asset Management Group, **PEDRO T. BAOY**, and Vice President of Program Services Division and Concurrent Acting Head of Information Technology Management Group, **ALAN GENE O. PADILLA**, duly authorized pursuant to Administrative Order No. 2022-032 dated 21 April 2022 (Annex "A") and Office Order No. 2022-026 dated 03 June 2022 (Annex "B"), hereinafter referred to as the "**SSS**";

TRENDS & TECHNOLOGIES, INC., a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 6th Floor Trafalgar Plaza, 105 H.V. Dela Costa Street, Salcedo Village, Makati City, represented herein by Account Director, **WILFREDO N. AGUILAR**, duly authorized pursuant to a Secretary's Certificate dated 04 July 2022 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Three (3) Year Maintenance Services of Network Equipment (165 Units Routers and Network Servers)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **FIVE MILLION SIX HUNDRED ELEVEN THOUSAND SIX HUNDRED SIXTY-SIX AND 67/100 PESOS (P5,611,666.67)** for the 1st Year or a Total of **SIXTEEN MILLION EIGHT HUNDRED THIRTY-FIVE THOUSAND PESOS (P16,835,000.00)** for Three (3) Years (hereinafter called "**the Contract Price**").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

In consideration for the sum of **FIVE MILLION SIX HUNDRED ELEVEN THOUSAND SIX HUNDRED SIXTY-SIX AND 67/100 PESOS (P5,611,666.67) for the 1st Year or a Total of SIXTEEN MILLION EIGHT HUNDRED THIRTY-FIVE THOUSAND PESOS (P16,835,000.00) for Three (3) Years** or such other sums as may be ascertained, **SUPPLIER** agrees to provide Maintenance Services of Network Equipment for the 165 Units Routers and Network Servers in accordance with its Bid.
4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
