THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Senior Vice President for Lending and Asset Management Group, **PEDRO T. BAOY**, and Vice President of Program Services Division and Concurrent Acting Head of Information Technology Management Group, **ALAN GENE O. PADILLA**, duly authorized pursuant to Administrative Order No. 2022-032 dated 21 April 2022 (Annex "A") and Office Order No. 2022-026 dated 03 June 2022 (Annex "B"), hereinafter referred to as the "**SSS**";

The **JOINT VENTURE** of **PHILIPPINE TELEGRAPH AND TELEPHONE CORPORATION**, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at Spirit of Communications Center, 106 Carlos Palanca St., Legaspi Village, Makati City, and **CATENA SECURITY, INC.**, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at Room 402, 4th Floor, G4s House, 142 Pasig Boulevard (Shaw Boulevard Extension), Pasig City, represented herein by **MAY Y. SARCEDA**, Attorney-in-Fact, duly authorized pursuant to a Resolution dated 16 September 2022 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Subscription of Primary 200 Mbps up to 500 Mbps for SSS Web Services for Main Office for Five (5) Years** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **FIVE MILLION SEVEN HUNDRED THIRTY-SIX THOUSAND PESOS (₱5,736,000.00)** (hereinafter called "**the Contract Price**").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.



In consideration for the sum of **FIVE MILLION SEVEN HUNDRED THIRTY-SIX THOUSAND PESOS (P5,736,000.00)** or such other sums as may be ascertained, **SUPPLIER** agrees to provide the 200 Mbps up to 500 Mbps Primary Subscription for SSS Web Services in Main Office for Five (5) Years in accordance with its Bid.
4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






