THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its Senior Vice President, Member Services and Support Group, **NORMITA M. DOCTOR**, and its Vice President and Acting Head, Administration Group, **DORENDA M. DASMARIÑAS**, duly authorized pursuant to Administrative Order No. 2022-089 dated 16 November 2022 (Annex "A") and Office Order No. 2022-026-b dated 16 December 2022 (Annex "B"), hereinafter referred to as the "**SSS**";

SUMMIT FURNISHINGS, INCORPORATED, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at 2634 Rockefeller Street, Barangay San Isidro, Makati City, represented herein by its Key Account Manager, **MARITA V. UMIPIG**, and its Vice President for Sales, **ALEXANDER REGALA**, duly authorized pursuant to a Secretary's Certificate dated 17 November 2022 (Annex "C"), hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the **Supply, Delivery and Installation of Modular Office System and Furniture for Various SSS Branch Offices [Lot 2: Luzon Branches – SSS Vigan, Baler, San Pedro, Tuguegarao and Tabaco]** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **PESOS: THIRTEEN MILLION SIX HUNDRED TWELVE THOUSAND NINE HUNDRED FIFTY-THREE AND 25/100 (P13,612,953.25)**, Philippine currency, (hereinafter called "the Contract Price").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:







1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.


- c. Performance Security;
- d. BAC I Recommendation for Award under Resolution No. 2022-I-090-2 dated 28 December 2022, approved on 29 December 2022; Notice of Award of Contract dated 29 December 2022 and the **SUPPLIER's** conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**


