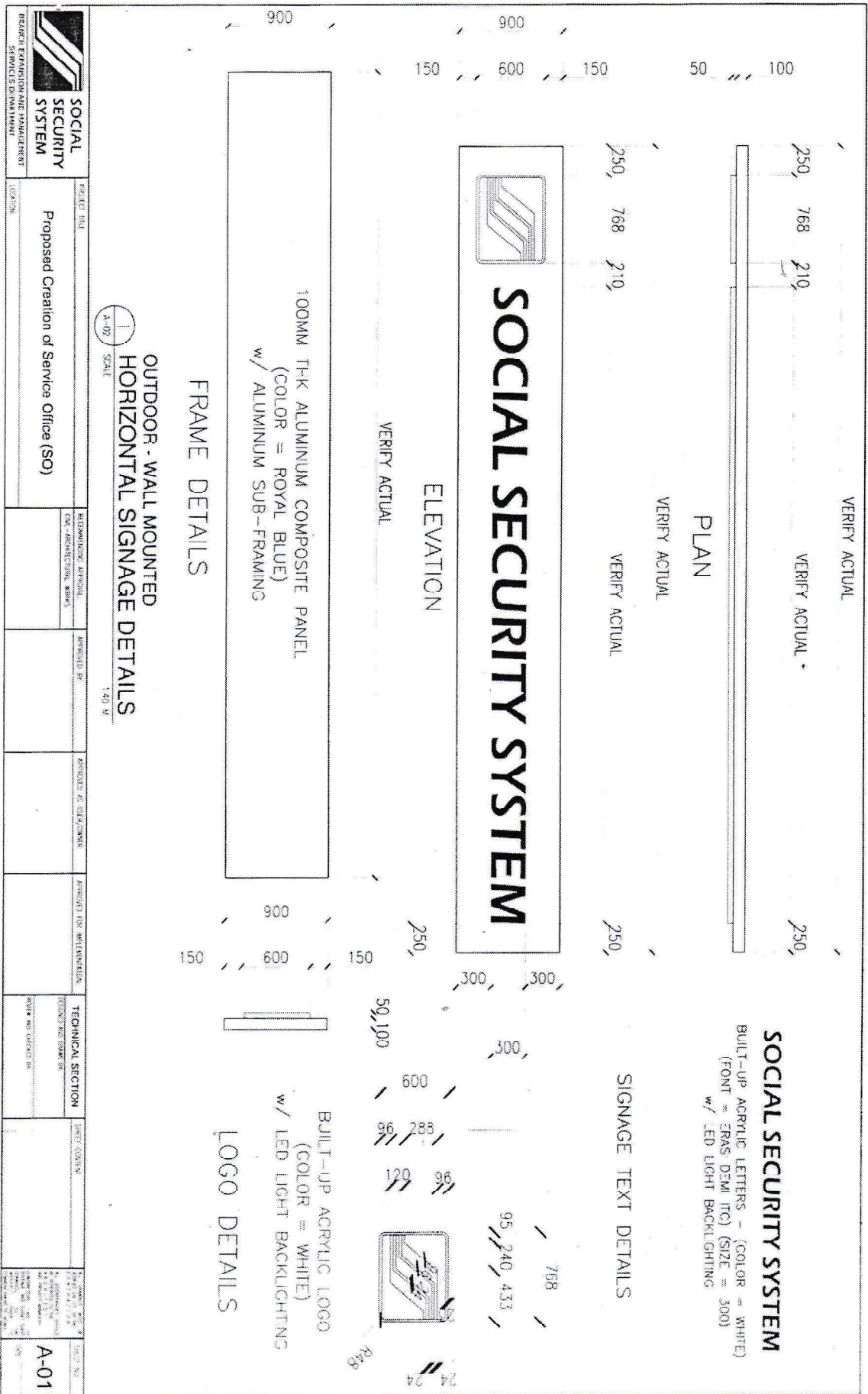

(Bid Security, Performance Security, Surety for advance payment, Warranty bond)
  - 4.3 Contingencies, Miscellaneous Expenses and Contractor's Profit margin
5. All drawings must be verified on site by the contractor. All discrepancies should be reported immediately to the architect and project managers. Contractors are to prepare and submit shop drawings to the architect prior to commencement of works
