- 4. Nobody secured the Bidding Documents at the time of the Pre-Bid Conference.
- 5. The Technical Working Group (TWG) presented the background, scope of work, and technical specifications of the project.
- 6. The following issues/clarifications were raised during the Pre-Bid Conference:

	Query/Clarifications	TWG/BAC Reply
6.1	On the Technical Specifications 5.1, should the medicines already in the market for the last 5 years?	Yes.
6.2	On the Technical Specifications 5.2, does the bidder need to submit the list of medicines supplied to its client?	Yes, as supporting documents.
6.3	If we submit the SLCC, can we just put the account number not the names of the medicines?	No. Bidders must include the names of the medicines.
6.4	Regarding on the Technical Specification 5.4, is the required expiration date must be less than 18 months?	Yes.
6.5	On the Technical Specification 5.10 (monthly monitoring), are the bidders required to submit the report to the SSS?	Yes. This is to monitor if the delivery is slow moving or fast moving.
6.6	Regarding the CPR, can the bidder submit the OR of the application for the renewed CPR with the tracking number if it is already expired?	Yes.
6.7	Will the contract be cancelled if the expiration of medicines is less than 18 months?	No, the bidder will be required to replace the medicines.
6.8	For the requirements for the on-going private and government contracts, does it need attachments such as OR/Contract?	No.
6.9	On the Single Largest Competed Contract, is it really 50% not 25%?	To be clarified through Bid Bulletin.

 - SEC/DTI Registration;
 - d) 2019 Mayor's Permit;
 - Valid Tax Clearance;
 - 2018 Audited Financial Statements filed through EFPS.
