

- a. Performance Bond within ten (10) calendar days from receipt of this notice but in no case later than the signing of the contract/Purchase Order/Job Order by both parties, equivalent to percentage of contract price as follows:
  - 5% in Cash, Cashier's/Manager's Check, Bank Guarantee/Draft, or
  - 30% Surety bond callable upon demand issued by a Surety or Insurance company duly certified by the Insurance Commission.
- b. A three (3) year warranty is required on all delivered goods and shall take effect upon complete installation and acceptance of the project by SSS. Said warranty, in addition to the provisions of GCC Clause 17, shall include the following:
  1. The Supplier warrants that should there be announced improvements on the proposed product and/or any of its components, after date of submission of proposals and before date of implementation, such improved product or its components shall be delivered to and installed at the SSS by the winning bidder without affecting the submitted bid price proposal.
  2. During the warranty period, SSS shall be entitled to all applicable software updates (OS, bundled software), security patches, and feature packs, if deemed necessary, at no additional cost to SSS.
  3. During the warranty period, the winning Supplier shall provide maintenance and technical support for hardware and/or software components of the proposal at no additional cost to SSS.

All maintenance and technical support shall be provided to SSS within two (2) hours from receipt of notice either through phone (hotline), electronic communication or written letter.
