- a. Performance Bond **within ten (10) calendar days from receipt of this notice**, equivalent to percentage of contract price as follows:
 - 5% in Cash, Cashier's/Manager's Check, Bank Guarantee/Draft, or
 - 30% Surety bond callable upon demand issued by a Surety or Insurance company duly certified by the Insurance Commission.
- b. Warranty of the equipment shall be 1 year. Within the warranty period, the supplier shall conduct the following:
 - Inspection/check-up and technical evaluation/recommendation of all units. To be done on the sixth month after completion and acceptance.
 - Oil change, replacement of air and fuel filter prior to the expiration of the warranty.
- c. Failure to comply the required works, the retention money will not be released unless full compliance.
- d. The period for correction of defects in the warranty period is within 24-hour from the time defect was first communicated (verbally or in writing) by Social Security System to the vendor.

The performance of the obligations under the awarded project will commence from the date of receipt of the Notice to Proceed.

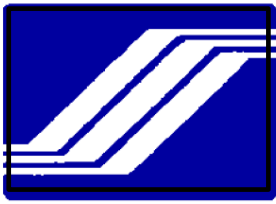
