  - During the warranty period, SSS shall be entitled to all applicable software updates (OS, bundled software), security patches, and feature packs, if deemed necessary, at no additional cost to SSS.

c. During the warranty period, the winning Supplier shall provide maintenance and technical support for hardware and/or software components of the proposal at no additional cost to SSS.


All maintenance and technical support shall be provided to SSS within two (2) hours from receipt of notice either through phone (hotline), electronic communication or written letter.
