- b. Warranty Security with the following validity period after the final acceptance by the Procuring Entity of the delivered Goods:



- c. The obligation for the warranty shall be covered by either retention money in an amount equivalent to five percent (5%) of every progress payment, or a special bank guarantee equivalent to five percent (5%) of the total contract price with validity period starting from the date of acceptance.
