

CONTRACT AGREEMENT

Acquisition of Network Equipment for Wireless Connectivity Infrastructure

THIS AGREEMENT made between:

SOCIAL SECURITY SYSTEM, a government-owned and -controlled corporation created pursuant to Republic Act No. 11199, with principal office address at SSS Building, East Avenue, Diliman, Quezon City, represented herein by its President and CEO, **MICHAEL G. REGINO**, duly authorized pursuant to Office Order No. 2017-047 dated 05 September 2017 (Annex "A"), hereinafter referred to as the "**SSS**";

The **JOINT VENTURE** of **MICROGENESIS SOFTWARE INC.** doing business under name and style of **MICROGENESIS BUSINESS SYSTEMS (MICROGENESIS)**, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at Unit 1202 Paragon Plaza Building, 162 EDSA cor. Reliance St., Mandaluyong City, and **MICRO GENESIS CFZ INC. (MICRO GENESIS CFZ)**, a corporation duly created and existing pursuant to the laws of the Republic of the Philippines, with principal office address at RM 5 Philexcel Business Park, M.A. Roxas Highway, Clark Freeport Zone, represented herein by Solution Sales Specialist of **MICROGENESIS**, **ROSEMARIE I. 
WHEREAS, the **SSS** invited Bids for certain goods and ancillary services, particularly the Acquisition of Network Equipment for Wireless Connectivity Infrastructure (**PROJECT**) and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **THIRTY-ONE MILLION SIX HUNDRED SEVEN THOUSAND THREE HUNDRED EIGHTY AND 11/100 PESOS (P31,607,380.11)**, Philippine currency, (hereinafter called "**the Contract Price**").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT** words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this **AGREEMENT**, viz.:

Other contract documents that may be required by existing laws and/or the SSS concerned in the PBDs. **SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **THIRTY-ONE MILLION SIX HUNDRED SEVEN THOUSAND THREE HUNDRED EIGHTY AND 11/100 PESOS (P31,607,380.11)**, Philippine currency, or such other sums as may be ascertained, **SUPPLIER** agrees to provide Network Equipment for Wireless Connectivity Infrastructure in accordance with its Bid.

4. **SSS** agrees to pay the above-mentioned sum in accordance with the terms and conditions of the Bidding.
