D. Minimum Bid Price : Lot No. 1: 45,361.74 Lot No. 2: 40,441.03 Lot No. 3: 60,417.89

The award shall be given to the highest complying bidder, as determined by the Committee.

 E. Payment : Payments shall be strictly in Cash or Certified Cashier's/Manager's Check payable to the Social Security System. The winning bidder shall be allowed to haul the sold lot only upon presentation of the Official Receipt of payments duly validated by the Chairperson of the Visayas West 1 Division Disposal Committee.

F. Eligibility Requirements:

G. Procedure of Bidding:

1. Every bidder must submit two (2) separate sealed envelopes with label containing the following:

*1st Envelope - Eligibility Requirements as stated above: "Application for Pre-qualification for <u>Public Auction/Bidding for the Sale and Disposal of Unserviceable Properties</u>

*2nd Envelope - Bid Security in the form of Certified Manager's/Cashier's Check or Cash equivalent to 10% of the total bid price; and properly accomplished Bid Tender Form(Sealed).

These two envelopes will be placed inside ONE BIG Envelope with proper label:

Envelopes should be submitted to the Secretariat of the Committee on or before 12:00pm, 20 October 2023 at the Office of the Vice-President, Visayas West 1 Division, 2 nd Fl, SSS Bacolod Branch Building, 2 nd Lacson St, Bacolod City.			

 A bidder may be allowed to withdraw his offer before the opening of the bid on or before 2:00pm of 20 October 2023. His bid shall be returned unopened.

- 3. The Committee shall open all the bids received at the date, time and place set in the Invitation to Bid. Bidders or their authorized representatives may witness the proceedings. The Committee shall declare the highest bidder. There should be at least two (2) submitted bid of qualified bidders in order for the public bidding to proceed. The 10% bid security shall be considered as advance payment. The second (2nd) highest bidder at his/her options may choose to refund or leave the 10% bid security in case the highest bidder is disqualified during the post qualification stage and the same shall be returned upon conferment of Notice of Award to the winning bidder.
- 4. The Committee shall, within two (2) working days from the date of the opening of the bids, validate the authenticity of eligibility documents submitted by the highest bidder.
- 5. The winning bidder, if not disqualified after the post qualification stage, shall be given the official Notice of Award and shall be required to pay the award price, inclusive of all government taxes, fees or duties, if any, and all incidental expenses, to the SSS within five (5) working days, from receipt of the said Notice.
- 6. A Deed of Absolute Sale shall be executed by the Social Security System and the Awardee as soon as the award price is paid.

H. Hauling of the Purchased Lot:

- 1. The winning bidder shall, at his own expense, be responsible for the packing, hauling, and loading the purchased lot to be done at the place indicated in the Invitation to Bid and in the presence of the authorized SSS personnel.
- 2. One-day hauling of the purchased lot shall be done any day from Monday to Thursday during office hours (9:00am to 4:00pm), not later than ten (10) days from the date of receipt of the Deed of Absolute Sale duly reviewed by OGCC thru DCD. If hauling cannot be completed within the specific time, the winning bidder can request for another one day for hauling provided that the request is justified and in writing.
- 3. Failure of the winning bidder to haul the purchased lot within the specified period shall result to the forfeiture of the payment/bid price in favor of the SSS.
- 4. The winning bidder shall guarantee the complete hauling and loading of all the property/equipment subject of the Contract, without any residual remaining within the premises of the SSS.
