COOLZONE REF AND AIRCON REPAIR AND SERVICES submitted its quotation amounting to Php 571,600.00. Supplier submitted its 2023 Mayor's Permit, PhilGEPS registration, 2022 Income Tax Return, and the Notarized Omnibus Sworn Statement. Terms of Reference (TOR) were completely accomplished, thus, bid is responsive.
