However, MCS (3) Diagnostic Center, and Specialist Healthcare Center Inc./Bacolod Diagnostic Center (1) failed to comply with the (eligibility) documentary requirements. Thus, BACD decided to award the procurement to 2 nd lowest bidder, that is QMA Diagnostic Center Inc./ Q Diagnostic Center having met the complete documentary requirements.
